(s) and e-mail address(es), the title of the paper and up to four keywords that describe the paper.

- The abstract and text for the full paper must include the title but must not include the author(s) name or affiliation anywhere in the text. There should be no content in the main paper that suggests the source of the author(s).
- The author(s) are requested to follow APA Citation Style.
- The main document should be double-spaced, with one-inch margins on all sides. All pages should be numbered consecutively. Font to be used: Times New Roman: 12 point (Main body Text); 14 point, Bold (Headings).
- All papers will be blind reviewed.
